Collection and Processing of Personal Data

We collect and process personal data only when you voluntarily provide it to us, for example, in the context of contacting us. Personal data includes:

- Name
- Email address
- Phone number (if provided)
- Other information you provide us in the course of your inquiry

Purpose of Data Processing

The data you provide will be used exclusively to:

- Respond to your inquiries
- Provide you with information about our services
- Communicate with you

Legal Basis for Processing

We process your personal data based on the following legal grounds:

- **Consent:** When you voluntarily provide us with data, you consent to us processing this data.
- **Contract Performance:** Processing your data is necessary to fulfill a contract or to take steps prior to entering into a contract based on your request.

Google Analytics

Our website uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses "cookies," which are text files placed on your computer to help analyze how you use the website. The information generated by the cookie about your use of the website is generally transmitted to and stored by Google on servers in the United States.

We have activated IP anonymization on this website. As a result, your IP address is truncated by Google within member states of the European Union or other parties to the Agreement on the European Economic Area before being transmitted to the United States. Only in exceptional cases will the full IP address be transmitted to a Google server in the United States and truncated there.

On behalf of the operator of this website, Google will use this information to evaluate your use of the website, compile reports on website activity, and provide other services related to website activity and internet usage to the website operator.

The IP address transmitted by your browser as part of Google Analytics will not be combined with other data from Google. - **Objection:** You can object to the processing of your data.
